Tax Avoidance Settlements

Menzies do not sell or promote tax avoidance arrangements, but we are pleased to take instructions from taxpayers or their advisers where there is an interest in understanding the cost of settlement and extricating themselves from historic planning.

We can leverage our relationships with HMRC's Counter Avoidance Directorate and request cases are allocated to individual caseworkers to take personal responsibility.

We ensure that clients settle on the best available settlement terms by undertaking a critical review of HMRC's settlement computations, ensuring only those liabilities that are legally enforceable are paid.



HMRC Enquiries and Compliance Checks

We are routinely appointed by other accountancy firms to assist them with HMRC enquiries and compliance checks into their own clients.

As well as having a breadth of knowledge covering all areas of UK tax, Menzies' TDD team have specialist knowledge in all UK tax administration matters. This includes HMRC powers, statutory time limits and penalties. These are all areas that continue to evolve and to ensure the most accurate advice is obtained our support is regularly called upon.



HMRC Disputes and Long-running Cases

The Menzies TDD team can provide strategic advice to taxpayers and/or their advisers to unlock difficult dispute cases, typically where HMRC are failing to respond or seem to be responsible for unacceptable delays; where HMRC's questions appear to be going off on a tangent; or the relationship with HMRC has broken down.

We represent and help clients settle their dispute using HMRC's **Alternative Dispute Resolution (ADR)** service when the case lends itself to this.

Our services - Tax Disclosures



Serious Tax Investigations (COP9/COP8)

Menzies are market leaders in advising clients in cases where actual or alleged errors/omissions have arisen from their deliberate behaviour. HMRC recommend taxpayers issued with Code of Practice 9 or Code of Practice 8 appoint an adviser, such as Menzies, who are highly experienced in managing such cases.

COP9 allows taxpayers to settle their deliberate errors or omissions on a civil basis and avoid criminal prosecution. Menzies has helped hundreds of taxpayers bring their tax affairs up to date with the threat of a criminal prosecution disappearing as a consequence of following our advice. Taxpayers can voluntarily apply for COP9 to correct their affairs and do not need to wait for HMRC to come calling.

COP8 is used where HMRC suspect a deliberate intention by the taxpayer to reduce their tax liability but there is no suggestion of tax fraud, as there is with COP9. COP8 is typically used by HMRC to investigate an individual's participation in tax avoidance arrangements.



Voluntary Tax Disclosures

In cases where a loss of tax did not arise from the individual's deliberate behaviour, Menzies's TDD team are vastly experienced in guiding clients through all tax disclosure facilities. This includes specific disclosure facilities where the following issues may be present:

- Where there is an offshore aspect to the disclosure, for example non-UK income and gains reportable in the UK but not previously declared, correction can be made through the Worldwide Disclosure Facility.
- Undisclosed income from residential property can be corrected through the Let Property Campaign.
- Correction of historic non-disclosure of cryptoasset transactions can be made through the Cryptoassets Disclosure Facility.
- Other dedicated disclosure facilities are announced from time to time which all follow a process that Menzies' TDD team are very familiar with.
- Disclosures that do not fall within any of the aforementioned disclosure facilities can be regularised through the Digital Disclosure Service.
